- Student numbers must be verified by the Dean's Office prior to the meeting of the Committee.
- The form must close at least three weeks prior to the Gala.
- The relevant committees must meet within 48 hours of the conclusion of the nomination period.
- Members of each relevant committee shall look over the results of the form, bearing in mind the purpose of each award and the relevant qualities of nominees to that purpose.
 - Prior to the committee's meeting, each member shall send their preliminary rankings to the Chair of the committee e.g. the President, VP Athletics, or VP External.
 - The Chair of that committee will schedule a meeting with all members present, barring exceptional circumstances, and discuss rankings and nominees for all awards.
 - Awards shall be allocated on the basis of merit and relevance of the nominee's engagement with the specific award criteria.

The Constitution must define club autonomy; affiliation with WCSA; "general member", "executive member" and the rights of each class of member; the hiring and/or voting process; mechanisms to amend the constitution. a. In order to remain valid, all clubs' statuses as a WCSA club must be re-ratified by the External Committee at minimum annually and after any revisions to that club's constitution. b. Clubs and the VP External must ensure that mechanisms for attaining all classes of club membership are reasonably accessible to all WCSA Members (as defined in Article III.1 of WCSA's Constitution).
- Club executives are officers of WCSA and must ensure they and their club abide by WCSA's Constitution, By-Laws, Policies, and directives.
- The External Committee may elect to fulfill the duties of the Elections and Referenda Committee with respect to clubs' elections.
- The External Committee may elect to name a sitting WCSA executive as CRO for clubs' elections.
- Any hiring to fill club positions shall be overseen by the VP External, who must be granted access to all application material, and who is required to ensure the hiring is conducted with principles of fairness and accessibility in mind.
- Clubs must be reasonably dedicated in contributing to the Woodsworth College community.

The authority to revoke the status of WCSA Club falls solely upon the External Committee, and requires either repeated or significant cause (such as violation of policy or their constitution, absenteeism, lack of communication, departure from the original mandate of the club, or fraud) or the request of two-thirds of the club's members, after a motion of ratification with the Board.
- 3. The VP External shall ensure clubs are provided with mechanisms to:
- a) request ample funding (at the discretion of the Board);
- b) communicate through WCSA's PR resources;
- c) reserve space in the college and residence for events, initiatives and meetings; and
- d) provide CCR validation to their members.
- 4. The VP External shall ensure clubs are intimately familiar with WCSA's policies, procedures, and expectations, as they apply to clubs and club executives.

This includes (but is not limited to) the required timeframes and procedures for booking spaces, responding to emails, requesting meetings, approving events, approving funding, requesting promotion of club materials, amending clubs' constitutions, etc.

- 5. Clubs must provide any information/updates regarding their club in a reasonable timeframe upon request of any WCSA Executive.
- 6. Clubs must regularly provide the VP External with complete, accurate lists of their members' names and any details necessary to verify their members' eligibility and to provide them with CCR.
- 7. Clubs must record minutes at any meeting and provide them to the VP External. The VP External is welcome to attend club meetings as they see fit.
- 8. Club Presidents must attend—or send a representative to attend—any meetings called by the VP External with a minimum one week of notice."

11. Gala Coordinator Update → Atique

- Over 280 tickets were sold, which is more than last year.
- We decreased the number of awards given out, which set up nicely for the 45 minutes of speeches supplemented by the reception, which was well received.
- The dietary restrictions were not entirely honoured. Some gluten-free individuals
- The Iftar boxes for those fasting were well received, but (5) went missing.
- (4) medals have gone missing.
- The food quality was great, and so was the photo booth and 360 camera.

- Jahan: Going forward, we should honour this format for the speeches and planning because it worked well. Thank you to all who helped!
- Shoutout to Gao and Wang for taking numerous pictures during the events as well.
- May need to refigure how we do registration, given time constraints.
 - Jahan: There was a lengthy waitlist, but we want to increase capacity. Registration was backlogged, and seating charts had some difficulties. Instead, permanent table cards should be done already so everyone knows exactly where they are sitting.

12. Orientation Coordinator Update → Giavedoni & Bansa

- Started reviewing applications, where some applications for positions like Leader Relations
 Coordinator have been received.
- Went through transition documents and other pertinent documents for hiring.
- Met with one another to discuss preliminaries and tentative plans to meet and discuss over the summer.
 - **Nebesny:** Is there a more recent update regarding the construction of Kruger Hall?
 - Atique: This is the most confident update since the initial construction plans were announced two years ago, and they are confident now that demolition will commence in June 2024.
- Looking for venues because Kruger Hall will not be accessible, seeing a replacement for that space.
 - Atique: One option is Varsity Stadium, though that is costly. It is difficult to find a
 space nearby because every College faculty member uses their own spaces for
 Orientation and large-capacity spaces will be booked. The Dean's Office is aware of this
 and will support the team with it.
 - Jahan: It is necessary to consider different types of events and go to different locations.
 Then, discuss this further with your team to provide better feedback and input.
 However, it is best to look for spaces outside of the campus and mitigate the cost by using public transit.
 - **Nebnesy:** The academic calendar will change next year. Is there an update on what and when Orientation will be?
 - Atique: We will take the whole week, counting Monday, or orientation begins a week early on the weekend, and we do not have this for Thursday and Friday. However, this has not been confirmed, and a discussion from the central administration of Student Life is to be announced. If there are more days included, then the days will be shortened.

- **Jahan:** Consult with what other colleges do for Orientation because they pack a few days, and Woodsworth is the only College that does a week-long Orientation. How is there a way to condense that in a meaningful way?
- **Fayed:** There should be half days because people are exhausted by the end of the day.
- **Atique:** This is a conversation to have with the Dean's Office, which is part of programming, and a collective decision to be made. Hopefully, by Thursday, there should be an answer as we have a Dean's Office meeting.
- Gouthro: How do we assist with Oriention in the capacity of being a director on WCSA?
 - **Atique:** Please show up to help.
 - **Jahan:** Keep up with the Board Chat, where the Board will ask for help from its members.
- We need to keep in mind that the Residence Move-In Day is important as well.
 - Atique: Residence Move-in Day has always been a challenge to coordinate around.
 Last year, it overlapped with Orienation Registration, which was difficult logistically.

13. Yearbook Payment Reminder → Wang

- If anyone would like to purchase a yearbook, ask now.
- You can pay with cash or a card.
- The order is being sent this Thursday.

14. Donation to Charitable Indulgence Announcement ->> Jain

- Charitable Indulgence is having its final charity event of the year for Palestine Relief. I am looking for WCSA to provide matching or contributions.
- We made close to \$9,300 following the matching.
- For bake sales, revenue is about \$3,000.
 - **Atique:** Open to doing a matching up to \$1,000, to be discussed.
- **Nebesny:** Is there a way that WCSA can help in a collaborative sense? Though this is a noble cause, funds are intended for Woodsworth students, which sets a dangerous precedent for providing funding to a charity that is not affiliated with the College or WCSA. Is there a way to make this a collaboration to avoid setting this precedent?
 - Atique: Charitable Indulgence is an outlier on that precedent since we have a strong connection through Jain being on the Charitable Indulgence team. They borrow our tables, and we routinely support them.

- The primary concern is finding a place to store items, and WCSA could provide space to do so collaboratively.
 - Nebesny: It is a good point that we have a strong connection because Jain is on the Board. However, numerous people are reaching out to request funding for clubs in support of collaborations, where the only answers are either (i) they can become a WCSA-affiliated club or (ii) they can do a collaborative event with WCSA, but funds cannot be provided because the mechanisms do not currently exist to provide funding in that capacity. The point is, if we are creating a mechanism for that, how will we do so equitably so that some clubs receive funds but others do not have any to do that?
 - Atique: The point still stands that there is no mechanism for charity, though there are two separate issues of charitable or club-related funds. That is something for the Policy Review Committee to consider.
 - **Kayed:** Perhaps we can create a fund?
 - **Atique:** There is potential for creating a fund since staff members have expressed interest in contributing to WCSA funds. That might be something for the next board Vice President of Finance, Kelash, to consider.
- The Policy Review Committee may revise the policy for funding, where the individual grant is revised to include an amount for charitable purposes.

15. Job Fair Alternative Discussion → Jain

- The job fair for Upper-Year Directors was immensely stressful, and the Dean's Office provided little support. A collaboration was planned but fell through, and a resume alternative was conducted with the help of the Woodsworth Alumni Association.
 - They enjoyed it and look forward to collaborating more often.
 - Looking into doing resume workshops on a more regular basis and mock interviews.
- Instead of having a Job Fair as one of the duties, looking to replace it with workshops regularly.
 - **Atique:** You are not required to have a Job Fair; the mandatory events are two Cram Jams and a Professional Development event.

16. Other Business

a. AGM Proxy Reminders ->> Atique

- The last board meeting will be at the end of April, and it will also serve as this Board's Annual General Meeting.
- This is mandatory and a legal requirement; if you cannot attend, you must have a proxy as someone attending in advance. Everyone in attendance must also have a proxy.
 - o (50) Woodsworth students must be present, whether virtual or in person.

- o If every Board Member receives a proxy, we can make a quorum.
- The meeting should not be more than 45 minutes.
- **Nebesny:** The *Constitution* requires us to let the public know the date of the AGM two weeks in advance.

b. Policy Recommendations ->> Atique

- The Policy Review Committee will meet soon; those within this committee expect an email from Atique.
 - Everyone → Please email Atique if you have a new policy you would like or a revision to an existing policy.
- It is our job to make things clear and have no ambiguity as well.
- All policy reviews will occur during the AGM.
 - Jahan: Can we recommend changes to the by-laws?
- Yes, anything policy-wise.
 - **Kelash:** When are people working outside of your portfolio?
- Yes, any Woodsworth student is welcome to email the President to do so.
 - Gweon: Why must we approve our budgets if the cost is already approved in the Event Approval Form?
- It is a good skill to budget and stay accountable to see what the funds are being spent on specifically.
 - **Souchet:** An additional question was added for a cost breakdown.
 - **Nebesny:** As expressed, some parts of the governing documents are quirky. Could you please briefly explain your philosophy on the scope of your role in Policy Review?
- Thinking holistically, I have grown in my perspective over my tenure. I want to release anyone of any ambiguity, with immediate answers provided within the provisions of the governing documents. There is a balance with discretion, where the President takes the decisions because they have the most oversight. Still, at the same time, that power should be limited to mission a level of accountability.
- My approach is typically to look at a policy and ask whether it has substance, whether
 something requires implementation, and, most importantly, if there is a reason for it to be
 implemented. If something has been indicated that this policy is necessary, not in theory. Every
 policy will be approached critically to ensure that every amendment is free of any gaps, with
 ample room to put it very carefully.
- Wording will be incredibly careful because it makes a big difference since there are several
 clauses that have ambiguous interpretations based just on one word. Recommendations may
 be amended to reflect the most accurate and least ambiguous.

- The election and awards policies are personally disliked and should be changed and reviewed. They will be made very clear before the conclusion of tenure.
- The Policy Review Committee votes as a whole on any amendments.
 - Everyone → If you have any concerns regarding policy, please email the President,
 Atique.
